(54) Title:	PYRETHRUM SOLAR DRIER

(57) Abstract: Shed and gable roof structures using solar radiation for drying pyrethrum flowers, inclined at 10° above latitude, and tightly fitted with clear polythene sheet to facilitate drainage of rainwater and enhance transmission of solar radiation into the drying chamber. Drying chamber is covered on all sides with exhaust vents restricted at the highest point on the roof to direct the flow of air from the drying chamber and enhance removal of moisture from the drying flowers. Constructed of wooden frame supporting papyrus mat tray, 0.8metres wide and 0.9metres above ground to facilitate manual stirring and avoid water splashing into the drying chamber. Inter spaces in papyrus mat allows free air circulation into the drying chamber from below the tray. Papyrus mat is a good heat absorber and retainer facilitating enhanced solar heat absorption and retention in the drying chamber.

(57) Abstract: The mineral vermiculite is a naturally occurring mineral that is found in various geological setting controlled by intense, temperature and geo-chemical processes. After the mineral is treated, it acquires attributes of fire proofing, sound deadening and cation exchange sites. (57) **Abstract:** A combination kit for the treatment of malaria caused by plasmodium vivax (P. Vivax) having individual doses of an anti-malarial agent, 3-[1-[[4-[(6-methoxy-8-quinoliny)amino]pentyl]amino]ethylidene]-dihydro-2(3H)-furanone (I) in the form of capsules; individual doses of the anti-malarial agent, chloroquine in the form of tablets; and instruction material for the administration of the two anti-malarial drugs. (57) **Abstract:** The present invention relates to methods and means of suppressing food-induced hypersensitivity reactions in patients suffering from food allergy. Particularly the invention provides methods of making a protein hydrolysate formula for downregulating hypersensitivity reactions and for promoting gut immune barrier, and methods of preventing or treating allergies, especially cow's milk allergy in infants by fortifying the cow's milk elimination diet with suitable probiotic bacteria derived from gastrointestinal tract, especially Lactobacilli. In addition, administering fragments of an allergen modified by gastrointestinal bacteria immune response can be "turned around" from sensitization to systemic hyporesponsiveness. (57) Abstract: Liquisolid systems are acceptably flowing and compressible powdered forms of liquid medications. According to the concept of liquisolid systems, liquid lipophilic drugs or water-insoluble drugs dissolved in suitable non-volatile solvents may be converted into free-flowing and readily compressible powders by simple admixture with selected powder excipients referred to as carrier and coating materials; a schematic outline of steps may be drawn for the process. Various grades of microcrystalline or amorphous cellulose may be used as carriers, whereas very fine particle size silica powders may be used as coating materials. Based on the theory that the carrier and coating materials can retain only certain amounts of liquid and at the same time maintain acceptable flow and compression properties, a new formulation-mathematical model is provided to calculate the optimum quantities of carrier and coating materials required to yield acceptably flowing and compressible liquid/powder admixtures.

In accordance with the invention, it has been observed that use of this formulation results in induced systemic resistance in a target plant. Also in accordance with the method of the invention, the formulation has been shown to trigger long-lasting, non-specific systemic resistance in the plant to a variety of pathogens and disease. Furthermore, the method of the invention results in an increase in the levels of plant isoflavones.
