The portable folded bag with pouch. The bag is folded and slid into the pouch which is attached to the bags' upper inner seam. The mouth of pouch is closed by adhesive tape that has been sewn on its mouth. The portable folded bags can conveniently be carried and used at appropriate time and place and will greatly reduce use of plastics which are not environmentally friendly.

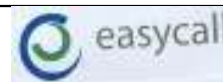
