This invention relates to a sanitary product (1) for use by women for the absorption of menstrual fluid and such like. The pad is made of cotton material manufactured in a honeycomb soft pattern with main sanitary pad cover. The pad is made of 100% cotton by drafting and drawing according to various sizes ranging from 2"x8" width and 4"x60" length. The pad is produced by stitching and over-locking, seaming or hemming to produce and oval soft cotton pad. To produce a pouch or cover, the above process is repeated and an impermeable or leak proof material is stitched in one to four absorbent towel layer wherein the inside of the pouch has a water proof lining on the lower part of the cover with an opening sheath (4).

The pouch is hemmed and stitched around. The product (1) comprises a pair of stitched loops on the sides of the pad (1). The loop (2) is substantially cylindrical so that it fits comfortably on the sides of the pad pouch before stitching over-locking and hemming measuring 2"x24". The pad (1) remains outside the vaginal cavity, but has an absorbent layer or layers on an inward side (5) proximal to the loop (2) and a string (3) measuring 1/8" x 2" width and 20" x 120" tied to the loop on an outward side (5). In use, a wearer can insert a finger into the sheath (4) from the outward side of the pad (1) assist with the string (3) to tie around the waist. When the product (1) is in place and the wearer's hand or finger has been removed, the pad (1) has sufficiently small diameter to avoid exerting any significant pressure on the vaginal orifice and vulva area. A string (3) is provided that extends inside the loop (2) from the outward end of the pad (1) to aid removal of the pad after use.

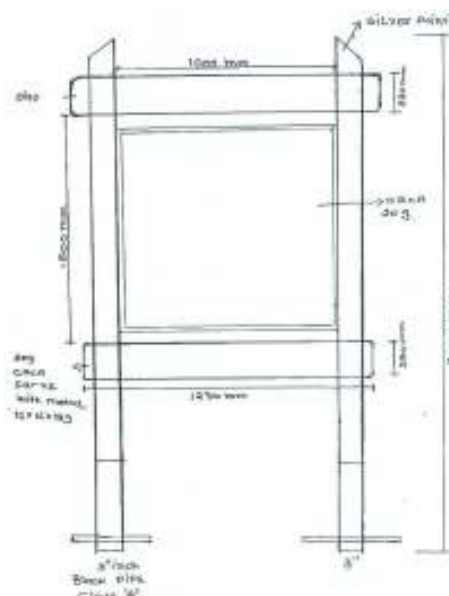

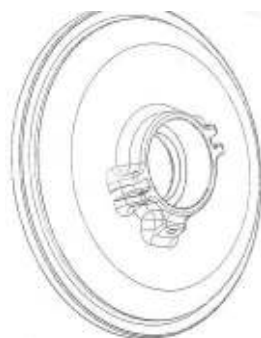

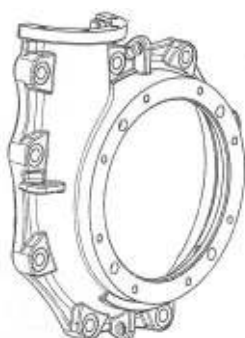
